#### VISION AND DISCERNMENT

Do you ever wonder where God is calling your community of faith? Do you feel as though you need some clear steps to help get there? The truth is that no one congregation can be all things to all people, but that does not mean that God doesn't have a plan for each of our communities. Join Pastor Justin Lingenfelter (United in Christ—West Milton) as he leads a workshop on Vision and Discernment to help us think about the ways Go calls each of our unique congregations to unique ministries. This workshop will include tangible tools, resources, and exercises to take home to your congregations to help you walk through a period of discernment and visioning towards producing a strategic plan for your church.

#### CHURCH FINANCES
