Preamble

We, baptized members of the Church of Christ, responding in faith to the call of the Holy Spirit through the Gospel, desiring to unite together to preach the Word, administer the sacraments, and carry out God's mission, do hereby adopt this constitution and solemnly pledge ourselves to be governed by its provisions. In the name of the Father and of the Son and of the Holy Spirit.

- Jesus as Lord
 - The Word proclaimed in Law & Gospel
 - The Word proclaimed in Scripture (inspired by God)
- Creeds
- Augsburg Confession
- Book of Concord


This congregation confesses the Gospel, recorded in the Holy Scripture and confessed in the ecumenical creeds and Lutheran confessional writings, as the power of God to create and sustain the Church for God's mission in the world.

Chapter 3: Nature of the Church

- Under rule and authority of Lord Jesus Christ
- Ecumenical (seeks Christian Unity)
- Three Expressions each is Church
- Global fellowship (LWF)


Chapter 4: Statement of Purpose

- Worship
- Proclaim
- Carry our Great Commission
- Serve
- Nurture
- Manifest Unity



Chapter 5: Powers of the Congregation

- Congregation Meeting
- Delegation to Council
- Call or terminate call
- Approve budget
- Amend Constitution
- Acquire, hold & sell property
- Elect to council and synod assembly



Chapter 6: Church Affiliation

- Defines relationship with ELCA and Synod
- And process for termination of relationship


Chapter 7: Property Ownership

- Congregation owns and controls its property
- At closure, property goes to synod
- Defines when congregation may retain ownership in cases of disaffiliation

Chapter 8: Membership

- Baptized
- Confirmed
- Voting
- Associate
- Seasonal

Council is responsible for approving and maintaining membership



Chapter 9: Rostered Minister

- ► ELCA Roster or Full-Communion
- Responsibilities of Pastor/Deacon
- Termination of call
- Bishop's responsibility

Chapter 10: Congregation Meeting

- Timing
- Quorum
- Notification

Chapter 11: Officers

- Four officers (President, Vice President, Secretary, Treasurer
- Officers serve same office in congregation and on council

Chapter 12: Council

- Number of members, terms, election
- Responsibilities
 - ► Financial, Property
- Planning & Oversight
- Relationship with Rostered Minister
- Example to congregation
- Promote Christian behavior

Chapter 13: Committees


- ► Four standing committees
 - Executive, Nominations, Mutual Ministry, Audit
- Call committee
- Others determined by congregation or council

Chapter 14: Organizations

Congregation has oversight and sets policies and goals
